Workshop Overview

You are invited to participate in the Great Lakes Commission sponsored workshop, *Rapid Response Plan for Great Lakes Aquatic Invasions* on July 23-24 at the Courtyard Marriott in Ann Arbor, Michigan. You are also welcome to participate in a meeting of the Great Lakes Panel on Aquatic Nuisance Species, preceding the rapid response workshop on July 22-23 at the same location. Support for the rapid response workshop and supporting project is provided by the U.S. EPA's Great Lakes National Program Office.

The rapid response workshop will focus on development of a model rapid response plan for Great Lakes aquatic invasions. The underlying goal of the plan is to increase capacity to anticipate, prevent and respond to new aquatic invasions of nonindigenous species in the Great Lakes region when applied on a state, provincial or regional basis. Plenary sessions for the workshop will introduce the need for rapid response planning and highlight other rapid response efforts applicable to Great Lakes aquatic invasions. Breakout sessions will provide an opportunity to build consensus for components of the model rapid response plan as work continues on their development. A closing session will facilitate discussion among various stakeholders on how to make rapid response plans operational to address Great Lakes aquatic invasions.
