Project: Risk Assessment Clearinghouse

- A research associate was hired to develop a process for populating the clearinghouse and to populate a first suite of seven regional risk assessment methodologies
- Population of assessments was completed in Dec. 2019 and responsibilities were transferred to NOAA-GLANSIS



GLP Priority Issues

Meetings

- GLP meetings were held biannually in the spring and fall of each work plan year
- Meetings in 2020 have all been held remotely due to the novel coronavirus pandemic

Executive Committee

• The GLP Executive Committee met regularly to plan for GLP meetings, coordinate GLP participation in the Aquatic Nuisance Species Task Force, and advance GLP priorities and recommendations with the ANSTF

January — February 2021


- *Staff:* Integrate GLP member feedback, note areas of disagreement, and present revised draft (V₃) with list of issues to resolve to GLP ExCom
- *GLP ExCom*: Review revised draft (V₃) and decide how to address any areas of disagreement

March – April 2021

- All: Resolve outstanding issues
- All: Review and approve final document (V4)

April – June 2021

- *GLP ExCom*: Distribute final priorities statement to relevant forums (e.g., ANSTF, GLRI, GLWQA)
- *All:* Identify and prioritize actions the GLP can take to address specific priorities
- GLP ExCom and Staff: Integrate actions into a new GLP work plan

June 2020 Action Items and Updates: OIT Ad Hoc Committee

OIT Symposium

- ✓ Successful funding proposal by MN/WI/PA Sea Grant, to support the symposium
 - As a committee member, Doug Jensen is managing proposal budget with NOAA and other partners
- ✓ Virtual sessions are planned over Winter 2021
 - 1st session will focus on enforcement and program perspectives on OIT
 - 2nd session on industry perspectives
- ✓ Staff have posted the draft agenda in a shared location for OIT members to provide input, and have had several planning calls with committee.

Next Steps for OIT Symposium

- Survey being drafted to get information from agency representatives on OIT programs and enforcement, to inform the 1st virtual session
- Draft inquiry to industry representatives to gauge interest and potential contributions to the 2nd virtual session
 - Committee members will identify potential industry contacts to reach out to and review the draft inquiry before distribution



Aquatic Plants: GLP priority issue

Aquatic Plants [Meeting Plenary Focus Session]

A plenary session was held on Case Studies in Aquatic Plant Response and Control at the June 2017 Great Lakes Binational Forum

Response case studies for aquatic plants were covered in a plenary session at the November 2018 GLP meeting



Goals and Objectives of Project

1. Provide operational support to regional AIS coordination activities through the GLP and engagement with other regional entities 2. Establish a comprehensive, baseline understanding of IAP research and management activities and associated gaps in knowledge

3. Conduct a workshop focused on priority IAP to refine and prioritize targeted research and management needs

4. Develop an applied research agenda to inform future investments in IAP control



Tasks

Task 1. Preliminary Assessment

- Regional management priority list of invasive aquatic plants
- Draft list of research questions and management needs for invasive aquatic plants
- Directory of principal investigators and experts and areas of expertise
- Inventory of aquatic plant control methods being developed and tested, and associated state, provincial, Tribal and federal authorities to implement specific methods

Task 2.

IAP Research and Management Workshop

- Workshop and associated documentation (e.g., summary of attendees, presentations and key outcomes)
- Inventory of know effective and non-effective control methods for priority plants, including gaps in method availability and barriers to implementation
- Draft prioritized list of research needs for each priority plant

Proposed Role of GLP



Great Lakes Panel

Budget

• Project funding: \$111,000

- \$101,000: award for project through interjurisdictional funding
- \$10,000: additional funding available through FWS for regional coordination
- \$11,000 budgeted for travel costs of staff, key experts, and speakers to the workshop and GLP meetings
- \$8,677 budgeted for workshop expenses
- Remaining funding is available for staff time to carry out primary project activities (meeting organization, compile and write reports, etc.)
